KNOW ALL MEN BY THESE PRESENTS, That DONALD L. BOYD and VELTA E. BOYD, husband and wife hereinafter called the grantor, for the consideration hereinafter stated, to grantor paid by DONALD K. RICHEY and KATHY MALLAMS RICHEY, husband and wife hereinafter called the grantee, does hereby grant, bargain, sell and convey unto the said grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Klamath and State of Oregon, described as follows, to-wit: Lot 5 in Block 7 of SECOND ADDITION TO SUNSET VILLAGE, Klamath County, Oregon

SUBJECT TO:

1. Regulations, including levies, liens, assessments water and irrigation rights, easements, rights of way of Enterprise Irrigation District, South Suburban Sanitary District and Sunset Lighting District.
2. Covenants, conditions, restrictions, reservations, rights, rights of way and easements now of record.

and that grantor will warrant and forever defend the said premises and every part and parcel thereof against the lawful claims and demands of all persons whomsoever, except those claiming under the above described encumbrances. The true and actual consideration paid for this transfer, stated in terms of dollars, is \$30,900.00
