KNOW ALL MEN BY THESE PRESENTS, That PRENTISS K. PUCKETT and BETTY C. PUCKETT, husband and wife, hereinafter called the grantor, for the consideration hereinafter stated, to grantor paid by KLAMATH COUNTY, a political subdivision of the State of Oregon, hereinafter called the grantee, does hereby grant, bargain, sell and convey unto the said grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Klamath and State of Oregon, described as follows, to-wit:

An undivided three-fifths interest in and to Lots 8, 9, 10, 11, 12, 13, 14 and 15, Block 6, McLOUGHLIN HEIGHTS in the City of Klamath Falls, Klamath County, Oregon.

SUBJECT TO: Future liens and/or assessments, if any; reservations, restrictions, easements and rights of way of record, and those apparent on the land.

To Have and to Hold the same unto the said grantee and grantee's heirs, successors and assigns forever. And said grantor hereby covenants to and with said grantee and grantee's heirs, successors and assigns, that grantor is lawfully seized in fee simple of the above granted premises, free from all encumbrances except as above set forth

and that grantor will warrant and forever defend the said premises and every part and parcel thereof against the lawful claims and demands of all persons whomsoever, except those claiming under the above described encumbrances.

The true and actual consideration paid for this transfer, stated in terms of dollars, is \$ 19,200.00

However, the actual consideration consists of the property of the grantor, which is the whole consideration (indicate which) of the undivided three-fifths interest in and to Lots 8, 9, 10, 11, 12, 13, 14 and 15, Block 6, McLOUGHLIN HEIGHTS in the City of Klamath Falls, Klamath County, Oregon.

In construing this deed and where the context so requires, the singular includes the plural and all grammatical changes shall be implied to make the provisions hereof apply equally to corporations and to individuals.
