DECREE OF DIVORCE

9 The above entitled matter came on for trial before the under-
10 signed judge on the 10th day of June, 1967, plaintiff appearing in
11 person and by and through Robert G. Chidester, of his attorneys, and
12 defendant appearing neither in person nor by attorney; and the State
13 of Oregon appearing by and through the District Attorney for Multnomah
14 County, Oregon, and plaintiff was sworn and testified, and an Order of
15 Default having been entered against the defendant for her failure to
16 appear and answer within the time required by law, and no testimony
17 being offered on behalf of the defendant, and the Court now being fully
18 advised in the premises and having found as a matter of law that the
19 plaintiff has sufficient grounds for a decree of divorce as alleged in
20 his complaint, now, therefore, it is

21 ORDERED, ADJUDGED AND DECREED that:

22 1. The marriage of the parties shall terminate on the 19th
23 day of August, 1967, or if an appeal is taken, then upon determination
24 of appeal, whichever is later, without further action of either party;
25 and

26 2. If either party shall die before said date, the marriage
27 shall terminate immediately before such death, unless an appeal is
28 pending; upon such death (if an appeal is pending), the estate of
29 defendant shall be the nominal party, and the Supreme Court shall have
30 the power to determine finally all matters presented on such appeal; and

31 3. Any will of either party antedating the date hereof is
32 revoked, unless its terms express a contrary intention; and

1 4. Neither party is entitled to cohabit with the other
2 from the date hereof, and

3 5. This decree may be vacated within sixty days from this
4 date or during an appeal, upon joint motion of the parties; and

5 6. Defendant, Rosemary Reeder, he and she hereby is awarded
6 the future care, custody and control of Joseph D. Reeder, a boy,
7 born July 3, 1948, subject to the right of the plaintiff to see and
8 visit said child at such reasonable times and places as will not
9 interfere with his education and welfare; and

10 7. Defendant he, and she hereby is, awarded and granted
11 as her sole and separate property, to the exclusion of any and all
12 rights therein of the plaintiff, the 1964 York trailer house and
13 miscellaneous items of household furniture, appliances and effects
14 located therein, and defendant he, and she hereby is, required and
15 directed to assume and pay the present balance owing thereon and to
16 hold plaintiff harmless therefrom; defendant he, and she hereby is,
17 granted and awarded as her sole and separate property, to the exclusion
18 of any and all rights therein of the plaintiff, the 1962 Oldsmobile
19 2-door hardtop, and defendant he, and she hereby is, required and
20 directed to assume and pay the present balance owing thereon and to
21 hold plaintiff harmless therefrom.

22 Plaintiff he, and he hereby is, granted and awarded as his
23 sole and separate property, to the exclusion of any and all rights
24 therein of defendant, the 555 shares of common stock of Tri-Port,
25 Inc.; plaintiff he, and he hereby is, granted and awarded as his sole
26 and separate property, to the exclusion of any and all rights therein
27 of defendant, that certain rental real property located at 2036 Lavey
28 Street, Klamath Falls, Oregon, and plaintiff he, and he hereby is,
29 required and directed to assume and pay the present indebtedness owing
30 thereon and to hold defendant harmless therefrom; plaintiff he, and
31 he hereby is, granted and awarded as his sole and separate property,
32 to the exclusion of any and all rights therein of defendant, the

1 1959 Cadillac convertible, and plaintiff be, and he hereby is,
2 required and directed to assume and pay the present balance owing
3 thereon and to hold the defendant harmless therefrom; plaintiff be,
4 and he hereby is, granted and awarded as his sole and separate
5 property to the exclusion of any and all rights therein of the
6 defendant, that certain undivided 1/5 vendor's interest in two
7 contracts of sale relating to real property located at 442 Grape
8 Street, Winston, Oregon, and at Ronald Street, Winston, Oregon;
9 plaintiff be, and he hereby is, granted and awarded as his sole and
10 separate property, to the exclusion of any and all rights therein of
11 defendant, those certain miscellaneous carpentry tools; plaintiff be,
12 and he hereby is, granted and awarded as his sole and separate property
13 to the exclusion of any and all rights therein of defendant, that
14 certain interest in A.C. Reeder & Son Kristen Dry-Wall; plaintiff be,
15 and he hereby is, granted and awarded as his sole and separate property,
16 to the exclusion of any and all rights therein of defendant, that
17 certain unknown number of shares of common stock of Hercules, Inc.;
18 plaintiff be, and he hereby is, granted and awarded to the exclusion
19 of any and all rights therein of defendant, that certain uncomputed
20 indebtedness owing by Tri-Port, Inc.

21 Plaintiff and defendant be, and they hereby are, granted
22 and awarded equally those certain federal and state income tax returns
23 for calendar year 1966, each to receive one half thereof.

24 Plaintiff be, and he hereby is, required and directed to
25 assume and pay all items of indebtedness to various creditors incurred
26 by plaintiff and defendant prior to October 25, 1966, and to hold
27 defendant harmless therefrom;

28 Plaintiff be, and he hereby is, required and directed to
29 assume and pay all items of "indebtedness" incurred by him subsequent
30 to October 25, 1966, and to hold defendant harmless therefrom; and
31 defendant be, and she hereby is, required and directed to assume and
32 pay all items of indebtedness incurred by her subsequent to October 25,

1 1966 and to hold plaintiff harmless therefrom.
