THIS MATTER came on for hearing on the application of JACK LYON for a Comprehensive Land Use Plan amendment accompanying Zone Change No. 74-41 by the Klamath County Planning Commission. A description of the real property referred to in the application is attached hereto, marked Exhibit "A" and incorporated by reference herein. A public hearing on said application having been regularly held on January 7, 1975 before the Board of County Commissioners and it appearing to said Board of Commissioners from the lack of testimony, reports and information produced at said hearing by the applicant that said applicant has withdrawn his zone change request and that the application should be denied. The Board of Commissioners makes the following Findings of Fact and Conclusions of Law as required by Ordinance No. 17, the Klamath County Zoning Ordinance:

Based upon no evidence showing location of the property, current use, use prior to the date of zoning, December 7, 1972, the current use of the parcel in question, the effect of the proposed zoning on adjacent properties and that the proposed change

of zone is in keeping with land use plans duly adopted by Klamath County;

NOW, THEREFORE, IT IS HEREBY ORDERED that the application of JACK LYON for a Comprehensive Land Use Plan amendment accompanying Zone Change No. 74-41 from Urban Density Residential to Commercial General on South Suburban Sheet No. 1 on a parcel of real property more particularly described in Exhibit "A", attached hereto and incorporated by reference herein is hereby denied and disapproved.
