Patzke, husband and wife, do hereby grant, bargain, sell and convey to the Bly Water District, Klamath County of Oregon, a perpetual easement for the installation, replacement, and repair or and maintenance of a water line, to be installed below the surface of the ground, together with rights of access thereto for the purposes stated, on, in and along the following described parcel of land:

The easterly 16.0 feet of the westerly 130.0 feet of that parcel of land conveyed in Vol M-69, Page 4680 of Klamath County Deed Records.

Together with the right of ingress and egress over the adjacent lands of the Grantor, his successors and assigns for the purposes of this easement.

IT IS EXPRESSLY UNDERSTOOD that this easement does not convey the right, title or interest to the surface of the soil, but only the reasonable use thereof, for the purposes here and above stated, not any other rights except those expressly stated in this easement, nor to prevent the grantors from the full use of the area for purposes not inconsistent with the easement.
