Subject to all reservations, restrictions, encumbrances and rights-of-way of record and those apparent upon the land.

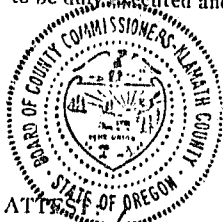
