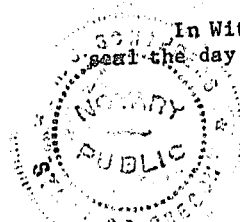

A portion of the S.E. 1/4 of Section 36, Township 30 South, Range 8 East of Willamette Meridian, in Klamath County, Oregon, more particularly described as follows:

Beginning at the Northeast corner of said Section 36; thence S. 60° 10' W., along the East line of said Section 36, 1770.16 feet, thence West, 520.41 feet, more or less, to the true point of beginning, which is an U.S. G.S. triangulation point; thence S. 67° 46' W., 203.61 feet; thence N. 32° 46' W., 129.3 feet; thence N. 46° 59' E., 117.12 feet; thence S. 40° 21' E., 472.86 feet, more or less, to the true point of beginning; containing 3.26 acres, more or less; and also an easement for an access road being ten (10) feet on either side of the centerline of an existing access road leading to and from the above described parcel of land, extending across portions of the S.E. 1/4 of Section 36, Township 30 South, Range 8 East of Willamette Meridian, and of the E. 1/2 of Section 31, Township 30 South, Range 9 East, of Willamette Meridian, more particularly described as follows:
