SUBJECT TO the following building and use restrictions, to-wit:

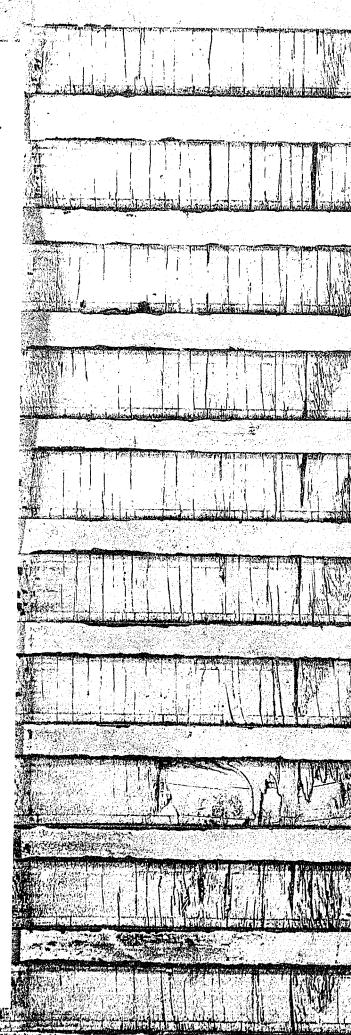
