KNOW ALL MEN BY THESE PRESENTS, that Klamath County, a public corporation of the State of Oregon, in consideration of the sum of ONE and NO/100 (\$1.00) DOLLARS, to it paid by HARRIMAN RURAL FIRE PROTECTION DISTRICT

of Klamath County, Oregon, does hereby grant, bargain, sell and convey unto the said HARRIMAN RURAL FIRE PROTECTION DISTRICT

and unto its heirs and assigns, all its right, title and interest in, and to the following described parcel of real estate, situated in the County of Klamath, State of Oregon, to-wit:

A tract of land situate within Lot 1, Pelican Acres, Klamath County, Oregon and being more particularly described as follows:

Beginning at an iron pipe on the East line of Lot 1, Pelican Acres, Klamath County, Oregon, from which the Auto Axel marking the Northeast corner of said Lot 1 bears N. 2° 01' 50" W. 100.28 feet distant; thence S. 89° 07' 50" W. 165.66 feet; thence S 17° 47' 50" W. 42.1 feet to the iron pipe marking an angle in the Northerly right-of-way of Aspen Lane; thence S. 0° 15' 30" W. 144.6 feet; thence around in a circular curve to the left with a radius of 20.0 feet, a distance of 31.81 feet; thence N. 89° 07' 50" E. 139.19 feet; thence around a circular curve to the left with a radius of 20.0 feet, 31.82 feet to the Westerly right-of-way of the Rocky Point Highway; thence N. 2° 01' 50" W. 184.59 feet, more or less to the point of beginning


Subject to "but if and when said property no longer is used as the location of a fire department building, the title therefor will revert to the County"


