

In the event vendoe shall fail to make the payments of oresaid, or any of them, punctually and upon the strict terms and at the times above specified, or fail to keep any of the other terms or conditions of this agreement, time of payment and strict performance being declared to be the essence of this agreement, then vendor shall have the following rights: (1) To foreclose this contract by strict foreclosure in equity; (2) to declare the full unpaid balance immediately due and payable; (3) To specifically enforce the terms of this agreement by suit in equity; (4) To declare this contract null and vold, and in any of such cases, except exercise of the right to specifically enforce this agreement by suit in equity, all the right and interest hereby created or then existing in favor of vendee derived under this agreement shall utterly coase and determine, and the premises aloresaid shall revert and revest in vendor without any declaration of torfeiture or act of teentry, and without any other act by vendor to be performed and without any right of vendee of reclamation or compensation for money paid or for improvements inade, as absolutely, fully and perfectly as if this agreement had never been made.

Should vendee, while in default, permit the premises to become vacant, Vender may take possession of same for the purpose of protecting and preserving the property and his security interest therein, and in the event possession is so taken by vender he shall not be deemed to have waived his right to exercise any of the foregoing rights.

And in case suit or action is instituted to foreclose this contract or to enforce any of the provisions hereof, vendee agrees to pay reasonable cost of title report and title search and such sum as the trial court may adjudge reasonable as attorney's fees to be allowed plaintiff in said suit or action, and if an appeal is taken from any judgment or decree of such trial court, the vendee further promises to pay such sum as the appellate court shall adjudge reasonable as plaintiff's attorney's fees on such appeal.

Vendee further agrees that failure by vendor at any time to require performance by vendoe of any provisions hereof shall in no way affect vendor's right horeunder to enforce the same, nor shall any waiver by vendor of such breach of any provision hereof be hold to be a waiver of any succeeding breach of any such provision, or as a waiver of the provision itself.

In construing this contract, it is understood that vender or the vendee may be more than one person; that if the context so requires the singular pronoun shall be taken to mean and include the plural, the masculine, the feminine, and the neuter, and that generally all grammatical changes shall be made, assumed and implied to make the provisions hereof apply equally to corporations and to individuals.

This agreement shall bind and inure to the benefit of, as the circumstances may require, the parties hereto and their respective heirs, executors, administrators and assigns.

It is understood and agreed by the parties hereto that there is a certain Contract dated May 22, 1974 between Ariston Yabes Vallejos, as Seller, and DAVID T. COOPER and FRANCES C. COOPER, husband and wife, as Buyers, which contract was subsequently assigned by David T. Cooper and Frances C. Cooper, as Assignors, to David T. Cooper and Kenneth W. Runft by assignment dated October 2, 1974, which Contract shall be paid by the Sellers herein and they shall hold the Buyers harmless thereon.
