ORDER APPROVING FINAL ACCOUNT  
AND DECREE OF FINAL DISTRIBUTION

Betsy Geary, executrix, having filed her final account and  
petition for decree of distribution, the court finds:

1. Betsy Geary, trustee of the Roland W. Geary Residuary  
Trust, the only person entitled to notice of hearing, has waived  
such notice and consented to the entry of an order approving the  
final account and a decree of final distribution.

2. All Oregon income, inheritance and personal property  
taxes, if any, have been paid and appropriate receipts, releases and  
clearances therefor have been filed.

3. The final account is in all respects proper and should  
be approved.

4. The partial distribution made pursuant to court order  
dated May 28, 1974, should be confirmed.

6 C. The allocation of Oregon inheritance and United States  
7 estate taxes set forth in the final account is approved.

8 D. The partial distribution made by the executrix is  
9 confirmed.

10 E. The persons named in paragraph 5 in the portions therein  
11 specified are hereby designated as the persons in whom title to the  
12 estate available for distribution is vested and the executrix is  
13 hereby directed to distribute the estate remaining after payment of  
14 all unpaid, necessary expenses incurred in the care, management and  
15 settlement of the estate in accordance with the decedent's will to  
16 said persons in the portions therein specified.

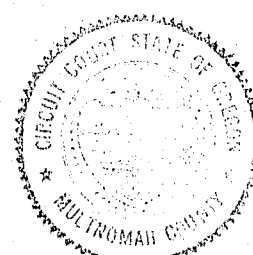
