Done by the order of the grantor's board of directors with it's corporate seal affixed, this 2nd day of October, 1975.

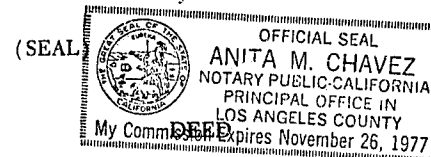
