## SUPPLEMENTAL AGREEMENT

THIS AGREEMENT, made and entered into as of the 15th day of September, 1975, by and between WEYERHAEUSER COMPANY, a Washington corporation, herein called "Weyerhaeuser", and STATE OF OREGON, acting by and through its Board of Forestry, herein called "State", WITNESSETH:

## RECITALS

Under date of April 23, 1971, the parties hereto entered into an Easement Exchange, as recorded May 17, 1971, in Vol. M71, at page 4427, Deed Records of Klamath County, Oregon, with respect to certain easements in Township 37 and 38 South, Range 12 East of the Willamette Meridian. The parties thereto now wish to amend said Easement Exchange as hereinafter set forth.

NOW, THEREFORE, in consideration of the premises and for the purpose of adding to the easements contained in said Easement Exchange, the parties hereto agree as follows:

1. Weyerhaeuser hereby grants to State a nonexclusive easement to construct, reconstruct, use and maintain a road across the following lands owned by Weyerhaeuser:

IN TOWNSHIP 37 SOUTH, RANGE 11 EAST OF W.M.

Section 25: E1/2SW1/4NW1/4; SE1/4NW1/4

IN TOWNSHIP 37 SOUTH, RANGE 12 EAST OF W.M.

Section 30: Government Lot 4

Subject as to said lands to all matters of public record. The location of said road shall be approximately as shown in red on

2. State hereby grants to Weyerhaeuser a nonexclusive easement to construct, reconstruct, use and maintain a road across the following lands owned by State:

IN TOWNSHIP 37 SOUTH, RANGE 11 EAST OF W.M.

Section 25: SW1/4NE1/4; SE1/4

IN TOWNSHIP 37 SOUTH, RANGE 12 EAST OF W.M.

Section 28: S1/2SW1/4; SW1/4SE1/4

Section 29: S1/2S1/2

Section 30: SE1/4SW1/4; S1/2SE1/4

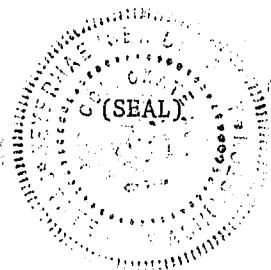
Section 31: N1/2NE1/4

Section 33: N1/2NE1/4

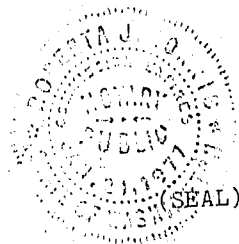

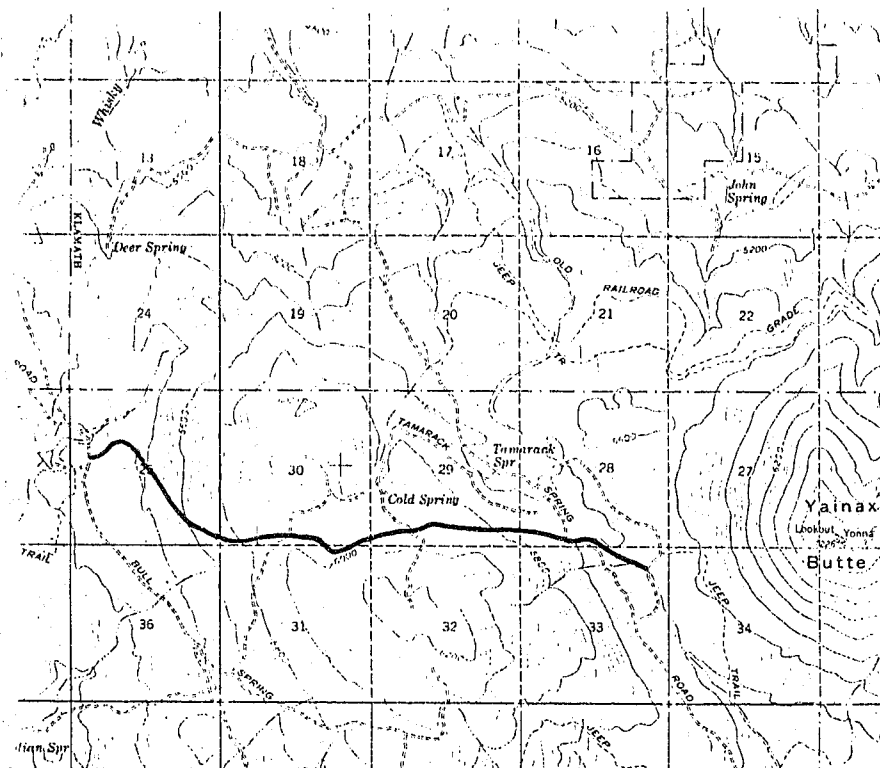
