FARM LABOR, SERVICE, LIVESTOCK OR MATERIALS LIEN

NOTICE IS HEREBY GIVEN That Albert and Geri Tanner claim a lien upon TWENTY FOUR HUNDRED AND SIXTY ONE (2,461) sheep pastured on the following described land in Klamath County, Oregon, starting October 5, 1975 by BEN LARALDE of Corning, California, to-wit:

PARCEL 1: That portion of the SE $\frac{1}{4}$ of Section 25, Township 32 South, Range 7 East of the Willamette Meridian, lying Easterly of the center thread of the Williamson River.

PARCEL 2: That portion of the NW $\frac{1}{4}$ of Section 25, lying Easterly of the center thread of the Williamson River, and the NE $\frac{1}{4}$ of Section 25, EXCEPT THEREFROM any portion lying West of the center thread of the Williamson River, all in Township 32 South, Range 7 East of the Willamette Meridian.

Said lien is also claimed upon the proceeds of any sale of any of said sheep. Said sheep are marked lll roughed colored on the back of said animals.

Said lien is claimed for pasturing of the aforementioned animals based upon the contract price being 2.5¢ per day, per head for three months or 90 days effective October 5, 1975 and with the provisions of ORS 87.294. The material furnished is the food provided for said animals as defined in ORS 87.292.

Said material was furnished said animals at the special instance and request of Ben Laralde who contracted with claimants for the furnishing of same. Claimant commenced furnishing said material on October 5, 1975 and the said Ben Laralde removed said livestock from claimant's property heretofore described October 17, 1975.

The name of the owner or reputed owner of said livestock so charged with this lien is Ben Laralde of Corning, California.

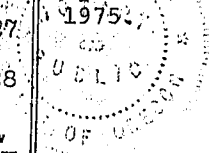
