Congress approved June 17, 1902 (32 Stat. 388) and acts amendatory
thereof or supplementary thereto, and particularly to the Act of

Congress approved October 2, 1974, entitled Reclamation Development
Act of 1974 (Title V, Public Law 93-493), which act authorized and
directed the Secretary of the Interior to convey certain unneeded
right of way of the United States to certain private landowners,
does in consideration of Seventy-five Dollars (\$75.00),

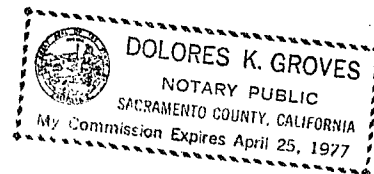
