Reservations, conditions and restrictions contained in plat dedication, to-wit: "A 20-foot building set-back line along the front of all lots, a minimum foundation area of 1200 square feet on single story residences, an eight foot easement along the back property lines of all lots for future sanitary sewers and public utilities, with right of ingress and egress for maintenance and construction with no structures permitted thereon and any plantings placed thereon at the risk of the owner, and a 20-foot easement along the front of Lot 1 for ingress and egress for construction and maintenance on the community well, and any further restrictions as may appear on individual deeds to lots."

5. Building setback line 20 feet from street as shown on dedicated plat.
