That for the purpose of providing regularly for the prompt payment of all taxes, assessments, and governmental charges levied or assessed against the above described property and insurance premium while the indebtedness accured hereby is in excess of 80% of the lesser of the original purchase price paid by the grantor at the time the loan was made, grantor will pay to the beneficiary in addition to the monthly payments of principal and interest payable under the terms of the note or obligation secured hereby on the date installments on principal and interest are payable an amount equal to 1/12 of the laxes, assessments, and other charges due and payable with respect to said property within each succeeding 12 months and also 1/36 of the hisurance premium payable with respect to said property within each succeeding three years while this Trust Deed is interest and said anounts at a rate not less than the highest rate authorized to be paid by banks on their open passhook accounts minus 8/4 of 1%. If such rate is less than 4%, the rate of interest paid shall be paid quarterly to the grantor by crediting to the secret account and shall be paid quarterly to the grantor by crediting to the secret account the amount of the interest due.

While the grantor is to pay any and all taxes, assessments and other charges leded or accessed against said property, or any part thereof, before the same begin to bear interest and also to pay preniums on all insurance policles upon said property, such payments are to be made through the beneficiary, as aforesaid. The grantor hereby authorizes the beneficiary to pay any and all taxes, assessments and other charges levied or imposed against said property in the amounts as shown by the statements thereof furnished by the collector of such taxes, assessments or other charges, and to pay the insurance carriers or their tep-resentatives and to withdraw the sums which may be required from the reserve account, if any, established for that purpose. The grantor agrees in no event to hold the beneficiary responsible for failure to have any insurance written or for any loss or damage grawing out of a defect in any insurance policy, and the beneficiary hereby is authorized, in the event of any loss, to compromize and settle with any insurance company and to apply any such insurance receipts upon the obligations accured by this trust deed. In computing the amount of, the indebtedness for payment and satisfaction in full or upon sale or other

property as in its sole discretion it may deem necessary or activable.

The grantor further agrees to comply with all laws, ordinances, regulations, covenants, conditions and restrictions affecting said property; to pay all costs, fees and expenses of this trust, including the cost of title search, as well as the other costs and expenses of the trustee incurred in connection with or in enforcing this obligation, and trustee's and attorney's fees actually incurred; to appear in and defend any action or proceeding purporting to affect the accurity hereof or the rights or powers of the beneficiary or trustee and to pay all costs and expenses, including cost of evidence of title and attorney's fees in a reasonable sum to be fixed by the court, in any such action or proceeding which the beneficiary or trustee may appear and in any suit brought by heneficiary to foreclose this deed, and all said sums shall be secured by this trust deed.

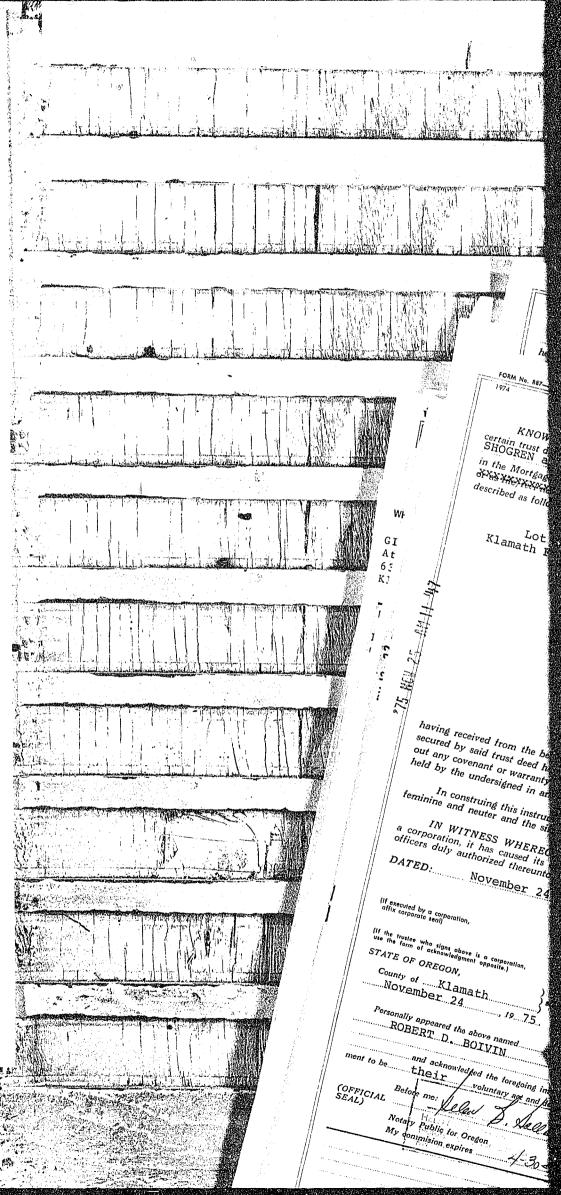
