

KNOW ALL MEN BY THESE PRESENTS: The undersigned, hereinafter called the claimant, did on the 24th day of October, 1975, enter into a contract direct with the owner of the real estate described below for the furnishing of materials and the performance of labor to be used in the construction of that certain improvement known as residence situated upon certain land in the County of Klamath, State of Oregon, described as follows:

The Southerly 38 feet of Northeasterly 17 feet of Lot 9, the Southerly 38 feet of Lot 10, Block 27, KLAMATH FALLS FIRST ADDITION, according to the duly recorded plat thereof on file in the office of the County Clerk of Klamath County, Oregon.

Said improvement is also known as 700 North Third Street in the City of Klamath Falls, Oregon. No. Street

Claimant commenced his performance of said contract on October 24, 1975, and completed his said contract on October 24, 1975.

At the time claimant entered into said contract and at the time claimant commenced the said work and the furnishing of said materials, Alois P. Hakenwerth, aka Al P. Hakenwerth, was the owner of said land and improvements and the person by whom claimant was employed and to whom claimant furnished materials; at all times herein mentioned, the said owner had knowledge of the construction of said improvement; on the date hereof Alois P. Hakenwerth, aka Al P. Hakenwerth, is the owner or reputed owner of said land and improvements.

The contract price and reasonable value of said labor and materials furnished for use and used in connection with said construction was and is \$261.47 and there is now due and owing claimant for the said materials so furnished and the labor performed, after deducting all just credits and offsets, the sum of \$261.47.

The following is a true statement of claimant's demand after the deductions mentioned above, to-wit:

In construing this instrument, the masculine pronoun means and includes the feminine and the neuter and the singular includes the plural, as the circumstances may require.
