28 In addition, said Grantor, his heirs, devisees and assigns, agrees to make an additional principal payment of \$50.00 each month commencing NNNN 15, 1976, 29 30 and continuing on the 15th day of each month thereafter until a total sum of \$331,25 has been paid on principal in order to reduce the principal balance to 31 what it would have been had the proper monthly installments been paid since 32
