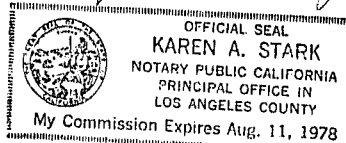
Grantor, for good and valuable consideration to it paid by Grantee, the receipt of which is hereby acknowl-
