KNOW ALL MEN BY THESE PRESENTS: The undersigned, hereinafter called the Claimant, has performed labor and rendered assistance in handling and transporting timber and wood products at the special insistence and request of Barden and Stocks Logging Company who at all times while said labor was being performed was the Original Contractor having charge of the transporting of various logs from the carrier area of Camp 2 (Weyerhaeuser land), each log being transported by the Claimant having attached to it a copy of the trip ticket issued to Barden and Stocks Logging Company, each trip ticket corresponding to the trip tickets listed below as part of the statement of claimant's demand, said land being situated in Klamath County, State of Oregon, more particularly described as follows:

Section 22, 23, 26 and 27, Township 32 South
Range 15 East of the Willamette Meridian,
Klamath County, State of Oregon.

Said labor was furnished to the Original Contractor who was the agent of the owner of said logs and the person by whom claimant was employed; at all times herein mentioned the owner had knowledge of the labor furnished and consented thereto on the dates of December 8, 10, and 11, 1975. Weyerhaeuser Company is the owner or reputed owner of said logs.

The reasonable value of said labor furnished by the claimant in handling and transporting the logs is the amount of \$1,115.16.

The following is a true statement of claimant's demand after the deductions mentioned above as of the date of filing of notice of claim of lien; whereby payment was due to claimant for his labor on December 18, 1975:

Claimant claims a lien for the amount last stated upon the logs at Weyerhaeuser plants in Bl, Oregon or the Weyerhaeuser reload facility, each log being tagged with a trip ticket corresponding to the trip ticket numbers listed in claimant's accounting above.

The time in which to file this claim of lien for recording with the recording officer of the County in which the logs are situated has not expired; sixty days have not elapsed after December 11, 1975, the date on which claimant ceased labor or furnish labor on said construction.

In construing this instrument, the masculine pronoun means and includes the feminine and the neuter and the singular includes the plural, as the circumstances may require.
