

ASSIGNMENT OF SELLERS' INTEREST IN CONTRACT OF SALE

KNOW ALL MEN BY THESE PRESENTS that LARRY W. HARRIGER, personal representative of the estate of Donald K. Harriger, deceased, assignor herein, for good and valuable consideration, receipt whereof is hereby acknowledged, has assigned and transferred to KENNETH B. HARRIGER, LARRY W. HARRIGER and JANET L. POST, as tenants in common with each owning an undivided one-third interest, assignees herein, that certain contract of sale dated August 8, 1973, between Donald K. Harriger, as seller and George F. McIntire and Sophia McIntire, husband and wife, as buyer concerning that certain real property more particularly described as follows:

The following described real property in Klamath County, Oregon:

PARCEL 1:

The South $\frac{1}{2}$ of the following described property: Beginning at a point on the Southeasterly right-of-way boundary of the Dalles-California Highway in the South-West Quarter of the Northwest Quarter of Section 20, Township 28 South, Range 8 East of the Willamette Meridian; which point of beginning is North, 940.8 feet; thence East 482.9 feet; and thence South $16^{\circ} 55'$ West 70.1 feet from the one-quarter corner common to Sections 19 and 20 in said Township and Range; thence South $16^{\circ} 55'$ West along said right-of-way boundary a distance of 50 feet; thence South $73^{\circ} 05'$ East 150 feet; thence North $16^{\circ} 55'$ East 50 feet; thence North $73^{\circ} 05'$ West 150 feet, more or less, to the point of beginning, being a portion of the Southwest quarter of the Northwest quarter of Section 20, Township 28 South, Range 8 East of the Willamette Meridian.

A portion of the West half of the Northwest quarter of Section 20, Township 28 South, Range 8 East of the Willamette Meridian, described as follows: beginning at a point on the Easterly right of way line of the Dalles-California Highway, which point is South along the Section line, 1667.8 feet; thence East, 491.6 feet and thence South $16^{\circ} 53' 30''$ West along the Easterly right-of-way line of said Highway, a distance of 150 feet; from the Section corner common to Sections 17, 18, 19 and 20, Township 28 South, Range 8 East of the Willamette Meridian; thence South $16^{\circ} 53' 30''$ West, along said right of way line, 100 feet; thence South $73^{\circ} 06' 30''$ East, 150 feet; thence North $16^{\circ} 53' 30''$ East, parallel to said right-of-way line, 100 feet; thence North $73^{\circ} 06' 30''$ West, 150 feet, more or less to the point of beginning; being a portion of said
