LOTS 19 AND 20 SITUATED IN THE VILLA ST. CLAIR SUBDIVISION. SAID SUBDIVISION IS SITUATED IN THE NORTHWEST QUARTER OF SECTION 14, TOWNSHIP 39 SOUTH, RANGE 9 EAST, WILLAMETTE MERIDIAN.

SAID RIGHT-OF-WAY FOR EXISTING FACILITIES LOCATED ON COUNTY ROAD WHICH WAS VACATED IN JANUARY 1975.

Together with the right of ingress and egress over the adjacent lands of the Grantors for the purpose of constructing, reconstructing, stringing new wires on, maintaining and removing such line and appurtenances, and exercising other rights hereby granted.
