of real estate, situated in the County of Klamath, State of Oregon, to-wit:

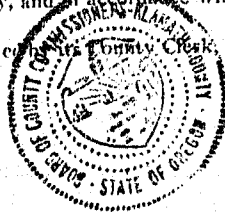
Lots 3 and 4, Block 3, South Chiloquin addition to the

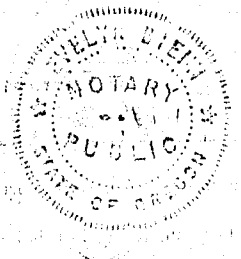
