

KNOW ALL MEN BY THESE PRESENTS, That **LEONARD DOERFLER or DOROTHY DOERFLER, husband and wife** the party of the first part, for value received, has granted, bargained, sold, assigned, transferred and set over, and by these presents does grant, bargain, sell, assign, transfer and set over unto **PACIFIC WEST MORTGAGE CO., an Oregon corporation** the party of the second part, that certain mortgage dated November 27, 1974, made and executed by **JOHN K.
