WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS, That Roy C. Sigler and Patricia L. Sigler husband and wife hereinafter called the grantor, for the consideration hereinafter stated, to grantor paid by Judy A. Jackson a married woman hereinafter called the grantee, does hereby grant, bargain, sell and convey unto the said grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Klamath and State of Oregon, described as follows, to-wit:

Beginning at a point 220 feet West and 365 feet North of SE Corner of the SE $\frac{1}{4}$ of the NE $\frac{1}{4}$ of Section 25, Township 24 South, Range 8 E.W.M.; thence North parallel with the East line of said SE $\frac{1}{4}$ of the NE $\frac{1}{4}$ 150 feet; thence West parallel with the North line of said SE $\frac{1}{4}$ of the NE $\frac{1}{4}$ 190 feet; thence South parallel with the East line of said SE $\frac{1}{4}$ of the NE $\frac{1}{4}$ 150 feet; thence East parallel with the South line of said SE $\frac{1}{4}$ of the NE $\frac{1}{4}$ 190 feet; to the point of beginning.

To Have and to Hold the same unto the said grantee and grantee's heirs, successors and assigns forever. And said grantor hereby covenants to and with said grantee and grantee's heirs, successors and assigns, that grantor is lawfully seized in fee simple of the above granted premises, free from all encumbrances

and that grantor will warrant and forever defend the said premises and every part and parcel thereof against the lawful claims and demands of all persons whomsoever, except those claiming under the above described encumbrances.

The true and actual consideration paid for this transfer, stated in terms of dollars, is \$ 3000.00. However, the actual consideration consists of or includes other property or value given or promised which is the whole consideration (indicate which) (The sentence between the symbols @, if not applicable, should be deleted. In construing this deed and where the context so requires, the singular includes the plural and all grammatical changes shall be implied to make the provisions hereof apply equally to corporations and to individuals.
