## GRANT DEED

We, GEORGE P. ANDRIEU and LEONA M. ANDRIEU, his wife, for and in consideration of the sum of THREE HUNDRED FIFTY AND NO/100 DOLLARS (\$350.00), lawful money of the United States to us in hand paid by THE UNITED STATES OF AMERICA, in pursuance of the provisions of the Act of June 17, 1902 (32 Stat. 388), and acts amendatory thereof or supplementary or applicable thereto, the receipt whereof is hereby acknowledged, do by these presents grants, bargain, sell and convey unto THE UNITED STATES OF AMERICA and its assigns, all that certain real property situate in the County of Klamath, State of Oregon, described as follows:

1. dients

A strip or parcel of land in Section Thirty (30), Township Forty (40) South, Range Nine (9) East, Willamette Meridian, County of Klamath, State of Oregon, containing an area of 3.1 acres, more or less, and described as follows:

Beginning at a point in the northerly boundary of said Section Thirty (30), distant therealong North 89° 53' West 1821.3 feet from the northeast corner of Section Thirty (30); thence leaving said northerly boundary South 27° 56' West 560.9 feet; thence South 02° 11' West 478.0 feet; thence South 13° 55' East 1474.2 feet; thence South 33° 49' East 152.8 feet; thence South 56° 25' East 35.7 feet to a point in the southerly boundary of the northeast quarter (NE4) of Section Thirty (30), distant therealong North 89° 51' West 1668.2 feet from the east quarter ( $E_{4}$ ) corner of Section Thirty (30); thence along said southerly boundary North 89° 51' West 90.0 feet; thence leaving said southerly boundary North 29° 47' West 143.7 feet; thence North 13° 55' West 1460.0 feet; thence North 02° 11' East 532.0 feet; thence North 27° 56' East 640.0 feet to said northerly boundary of Section Thirty (30); thence therealong South 89° 53' East 51.0 feet to the point of beginning.

SUBJECT to existing rights of way, of record or in use, for roads, railroads, telegraph, telephone and electrical transmission lines, canals, laterals, ditches, flumes, siphons and pipelines, on, over and across said premises; and

SUBJECT to existing estates, interests and rights in and to coal, oil, gas and any and all other minerals reserved to or outstanding in third parties; and

Reserving to Grantor, their heirs, executors, administrators and assigns, the non-exclusive right to travel for agricultural purposes over and across the easterly drain embankment road from Grantor's south property line, which is the east-west centerline of Section 30, Township 40 South, Range 9 East, W.M., Klamath County, Oregon (approximate Station 260+00), northerly to Grantor's north property line, which is the northerly boundary of said Section 30 (approximate Station 295+00).

Reserving to Grantor, their heirs, executors, administrators and assigns, all of their interest in and to all oil, gas or minerals in or under said land, without, however, the right to dig, drill or mine therefor through the surface of said land, or within 100 feet of the surface.

The above reserved rights of way shall be so exercised as not to interfere with the use of the land by the United States or endanger facilities of the United States on said lands.
