WHEREAS, in a suit in the Circuit Court of the State of Oregon for Klamath County between First Federal Savings and Loan Association of Klamath Falls, a federal corporation, as plaintiff, and Shadow Hills Development Corporation, an Oregon corporation, William F. Hannon, Robert E. Hannon and John P. Hannon as defendants, a judgment and decree was entered on March 7, 1975, for the foreclosure of a mortgage on the real property described below, and

WHEREAS, the Court thereafter issued a writ of execution and, pursuant thereto, on April 17, 1975, all of the interest of the defendants in the real property was sold at public auction subject to redemption in the manner provided by law for the sum of \$136,778.13 to First Federal Savings and Loan Association of Klamath Falls, the highest bidder, and
