

## STATEMENT

1 I, SHELBY ADAMS, and I, ROGER A. ADAMS, state:

2 That on May 25, 1973, we signed an Agreement. Said  
3 Agreement was for the purchase of land described as follows:

4 Lot 29 Lewis Tracts, according to the Recorded Plat thereof,  
5 Subject to easements and rights of way of record or apparent  
6 on the land; Contract and/or lien for irrigation or drainage,  
and to rules, regulations and assessments of the South  
Suburban Sanitary district.

7 To the best of our knowledge Frederick D. Ehlers and  
8 Helen A. Ehlers signed this Agreement. We witnessed Frederick D.
