If the ladebtedness secured by this trust deed is evidenced by than one note, the beneficiary may credit payments received by it upon of said notes or part of any payment on one note and part on another, he beneficiary may elect.

The grantor hereby covenants to and with the trustee and the beneficiary herein that the said premises and property conveyed by this trust deed are free and clear of all encumbrances and that the grantor will and his heirs, executors and administrators shall warrant and defend his said title thereto against the claims of all persons whomsoever.

The grantor covenants and agrees to pay said note according to the terms thereof and, when due, all taxes, assessments and other charges levied against asid property; to keep said property free from all encumbrances having precedence over this trust deed; to complete all buildings in course of construction or hereafter constructed on said promises within six months from the date hereof or the date construction is hereafter commended; to repair and restore promptly and in good workmanike manner destroyed and pay, when due, all costs incurred therefor; to allow beneficiary to inspect said property at all times during construction; to replace any work or materials unsatisfactory to beneficiary within fifteen days after written notice from beneficiary of such act, not to remove or destroy any building or improvements now or hereafter exceted upon said property in good repair and to commit or suffer now waste of said premises; to keep all buildings, property and improvements now or hereafter exceted on said premises continuously insured against loss by fire or such other hazards as the beneficiary may from time to time require, in a sum not less than the original premises accontinuously insured against loss by fire or such other hazards as the beneficiary may from time to time require. sharm the hole-centerication by the gratical and anomal meter between the parameter of all taxes, assessments, and governmental charges levid or assessed against the above described property and insurance prendum while the indebtedness secured hereby is in excess of 80%, of the lesser of the original purchase price paid by the grantor at the time the loan was made or the beneficlary's original appraisal value of the property at the time the loan was made grantor will pay to the beneficiary in addition to the monthly paramets of principal and interest payable under the terms of the note or obligation secured hereby on the date installments on principal and interest are payable an amount equal to 1/12 of the taxes, assessments, and other charges due and payable with respect to said property within each succeeding 12 months and also 1/36 of the insurance prendum payable with respect to said property within each succeeding three years while this Trust beed is in effect as estimated and directed by the beneficiary, heneficiary shall pay to the grantor interest on said amounts at a rate not less than the highest rate authorized to be paid by banks on their open passbook accounts minus 3/1 of 1%. If such rate is less than 40%, the rate of interest paid shall be 4%. Interest shall be computed on the average monthly balance in the account and shall be paid quarterly to the grantor by crediting to the serrow account the amount of the interest due.

While the grantor is to pay any and all taxes, assessments and other charges leded or assessed against said property, or any part thereof, before the same begin to bear laterest and also to pay premiums on all insurance policies upon said property, such payments are to be made through the beneficiary, as aforesaid. The grantor brethy authorizes the beneficiary to pay any and all taxes, assessments and other charges leded or imposed against said property in the amounts as shown by the statements thereof furnished by the collector of such taxes, assessments or other charges, and to pay the insurance premiums in the amounts shown on the statements studing the time that the statements thereof furnished by the collector of such taxes, assessments submitted by the insurance tarriers or their representatives and to withdraw the sums which may be required from the reserve account, fany, established for that purpose. The grantor agrees in no event to hold the beneficiary responsible for failure to have any insurance written or for any loss or damage growing out of a defect in any insurance policy, and the beneficiary brethy is authorized, in the event of any loss, to compromise and settle with any insurance company and to apply any such insurance receipts upon the obligations secured by this trust deed. In computing the amount of the indebtedness for payment and satisfaction in full or upon sale or other

acquisition of the property by the beneficiary after default, any balance remaining in the reserve account shall be credited to the indebtedness. If any authorized reserve account for taxes, assessments, insurance premiums and other charges is not sufficient at any time for the payment of such charges as they become due, the grantor shall pay the deficit to the beneficiary upon demand, and if not paid within ten days after such demand, the beneficiary may at its option add the amount of such deficit to the principal of the obligation secured hereby.

Should the grantor fail to keep any of the foregoing covenants, then the efficiary may at its option carry out the same, and all its expenditures thereshall draw interest at the rate specified in the note, shall be repsyable by grantor on demand and shall be secured by the lien of this trust deed, in connection, the beneficiary shall have the right in its discretion to complete improvements made on said premises and also to make such repairs to said perty as in its sole discretion it may deem necessary or advisable.

The grantor further agrees to comply with all laws, ordinances, regulations, vecanits, conditions and restrictions affecting said property; to pay all costs, es and expenses of this trust, including the cost of title search, as well as e other costs and expenses of the truster incurred in connection with or enforcing this obligation, and trustee's and attorney's fees actually incurred; appear in and defend any action or proceeding purporting to affect the secury hereof or the rights or powers of the beneficiary or trustee; and to pay all a asonable sum to be fixed by the court, in any such action or proceeding in thich the beneficiary or trustee may appear and in any sult brought by beneficiary to forselose this deed, and all said sums shall be secured by this trust red.

The beneficiary will furnish to the granter on written request therefor an annual statement of account but shall not be obligated or required to furnish any further statements of account.

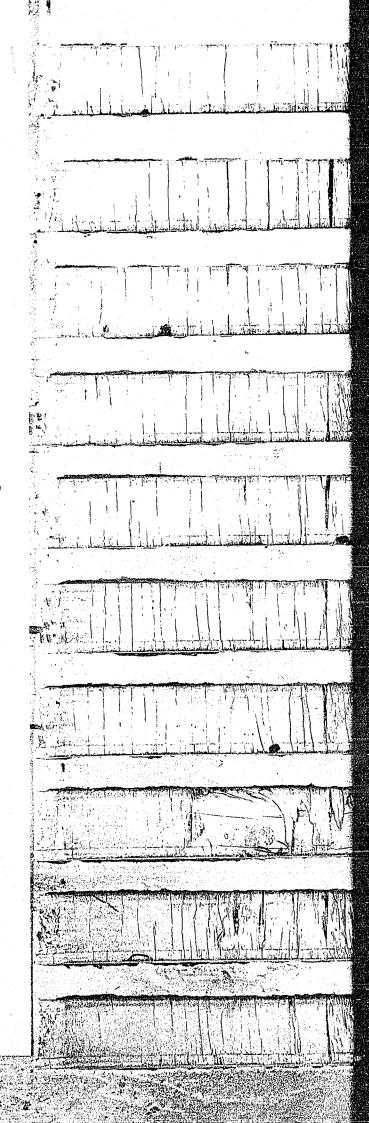

1. 3. As additional security, grantor hereby assigns to beneficiary during the continuance of these trusts all rents, issues, royalties and profits of the property affected by this deed and of any personal property located thereon. Until grantor shall default in the payment of any indebtedness secured hereby or in the performance of any agreement hereunder, grantor shall have the right to collect all such rents, issues, royalties and profits earned prior to default as they become due and payable. Upon any default by the grantor hereunder, the beneficiary may at any time without notice, either in person, by agent or by a receiver to be appointed by a court, and without regard to the adequacy of any security for the indebtedness hereby secured, enter upon and take possession of said property, or any part thereof, in its own name sue for or otherwise collect the rents, issues and profits, including those past due and unpaid, and apply the same, less costs and expenses of operation and collection, including reasonable attorney's fees, upon any indebtedness secured hereby, and in such order as the beneficiary may determine.



4. The entering upon and taking possession of said property, the collection of such rents, issues and profits or the proceeds of fire and other insurance policies or compensation or swards for any taking or damage of the property, and the application or release thereof, as aforesaid, shall not cure or waive any default or notice of default hereunder or invalidate any act done pursuant to such notice.

The grantor shall notify beneficiary in writing of any sale or contract for sale of the above described property and furnish beneficiary on a form supplied it with such personal information concerning the purchaser as would ordinarily be required of a new loan applicant and shall pay beneficiary a service charge.
