CORRECTION DEED

CARTIER, tenants in common, hereinafter called the "Grantees," do hereby grant, bargain, sell and convey unto the said Grantees and Grantees' heirs, successors and assigns, that certain real property with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the county of Klamath, state of Oregon, described as follows:

The North 360 feet of Lot 9, Block 18, KLAMATH FALLS FOREST ESTATES SYCAN UNIT, as recorded in Klamath County, Oregon.

and subject to all conditions, restrictions, reservations, easements, exceptions, rights and/or rights of way affecting said property.

To have and to hold the above described granted premises unto the said Grantees and Grantees' successors, heirs and assigns forever.

Said Grantors hereby covenant to and with said Grantees and Grantees' successors, heirs and assigns, that Grantors are lawfully seized in fee simple of the above granted premises, free from all encumbrances and that Grantors will and Grantors' successors shall warrant and forever defend the above granted premises and every part and parcel thereof against the lawful claims and demands of all persons whomsoever.

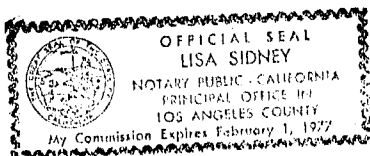

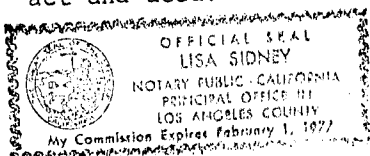
