And said mortgagor covenants to and with the mortgagee, his heirs, executors, administrators and assigns, that he is lawfully seized in tee simple of said premises and has a valid, unencumbered title thereto

and will warrant and torever detend the same against all persons; that he will pay said note, principal and interest, according to the terms thereof; that while any part of said note remains unpaid he will pay all taxes, assessments and other charges of every nature which may be levied or assessed against said property, or this mortfage or the note above described, when due and payable and before the same may become delinquent; that he will promptly pay and satisty any and all liens or encumbrances that are or may become liens on the premises or any part thereof superior to the lien of this mortfage; that he will keep the buildings now on or which hereafter may be erected on the said premises continuously insured against loss or damage by tire and such other hazards as the mortfagee may from time to time require, in an amount not less than the original principal sum of the note or obligation secured by this mortfage, in a company or companies acceptable to the mortfagee, with loss payable lirst to the mortgagee and then to the mortfager as their respective interests may appear; all policies of insurance shall be delivered to the mortfagee as soon as insured.
