
THIS MEMORANDUM OF GEOTHERMAL LEASE MODIFICATION AND AMENDMENT, dated June 1, 1976, by and between O'Connor Livestock Co., a corporation, Frances O'Connor Enterprises, Inc., David R. Vandenberg, Jr. and Muriel M. Vandenberg, his wife, hereinafter called "Lessor" and THERMAL POWER COMPANY, a corporation, hereinafter called "Lessee".

WHEREAS, Lessor and NATOMAS COMPANY, a corporation have entered into that certain Geothermal Lease and Agreement dated November 11, 1974, a Memorandum of which Lease was recorded in Volume M74, Page 15542, Official Records of Klamath County, Oregon and,

WHEREAS, by instrument dated July 31, 1975, Natomas Company transferred and assigned to THERMAL POWER COMPANY, a corporation all of its right, title and interest in and to said Geothermal Lease and Agreement which instrument was recorded in Volume 75, Page 9695, Official Records of Klamath County, Oregon and,

WHEREAS, by Agreement dated June 1, 1976, said Geothermal Lease and Agreement was modified and amended to grant to the Lessee thereunder sole and exclusive right to explore, drill, mine and/or operate for oil, gas or other hydrocarbon substances upon the terms and conditions therein set forth.



NOW THEREFORE:

In consideration of the premises it is hereby mutually 9009 agreed that the term, rental and royalties to be paid by Lessee and all other agreements, covenants, conditions, obligations and priviliges of Lessor and Lessee herein shall be those set forth in that certain Geothermal Lease and Agreement dated November 11, 1974, as modified and amended by that certain Agreement between Lessor and Lessee dated June 1, 1976, which said Lease, Modification and Amendment Agreement is hereby adopted and by reference made a part hereof with the same force and effect as though said Geothermal Lease and Agreement and said Modification and Amendment Agreement were herein copied in identical words and figures.
