Eleven Thousand Dollars (\$11,000) to be paid to the order of Sellers in monthly installments of not less than One Hundred Eleven and 57/100 Dollars (\$11.57) commencing June 1, 1976, with like payments being due on the first of each month thereafter and continuing until said purchase price is fully paid, all of said purchase price may be paid at any time; all deferred balances of said purchase price shall bear interest at the rate of nine percent (9%) per annum from the date of this contract until paid, interest to be paid monthly and being included in the minimum monthly payments above required.

All of the remaining provisions of said contract of sale shall remain in full force and effect and said contract shall be amended only as set forth herein.
