

BARGAIN AND SALE DEED

KNOW ALL MEN BY THESE PRESENTS, That Norman J. and Darlene Ray and Irene Byrne, husband and wife & Orrla L. and Shirley Stuempfle and Irene Byrne, husband and wife & Orrla L. and Shirley Stuempfle for the consideration hereinafter stated, do hereby grant, bargain, sell and convey unto the hereinabove named husband and wife, their heirs, successors and assigns all of the tenements, hereditaments and appurtenances thereto belonging or in anywise appertaining in Klamath County, Oregon, described as follows, to-wit:

A strip of land for road purposes being more particularly described as follows:

Beginning at the Northeast corner of Lot 1, Block 57, 3200, Washburn Park, a recorded subdivision in Klamath County, N. 89°25'10"E., 231.72 feet; thence N. 00°04'50"E., 320.00 feet to the true point of beginning of this description; then to the northeast corner of the property described in M72, page 7543 of the Klamath County Deed Records; thence N. 89°25'10"E., 320.00 feet to the North line of the property described in M72, page 7543, 320.00 feet; thence S. 25'10"E., 320.00 feet to the East right-of-way line of Washburn Way; thence S. 25'10"E., 320.00 feet along the East right-of-way line of Washburn Way and to the point of beginning.

To have and to hold the same unto the above named grantee, his heirs, successors and assigns forever, for the sum of \$0.00, or such amount as may be determined in terms of dollars, is \$0.00.
