A piece or parcel of land situated in the SE $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 30, Township 39 South, Range 9 East of the Willamette Meridian in Klamath County, Oregon, being more particularly described as follows: Beginning at the point of intersection of the Southerly boundary of Section 30, Township 39 South, Range 9 East of the Willamette Meridian, and a line parallel with and 50.00 feet distant at right angles southeasterly from the centerline of the Klamath Falls-Midland section of the Oregon State Highway, as the same is presently located and constructed, and from which point of intersection the Southwesterly corner of said Section 30 bears South 89 degrees 42' 30" West, 827.1 feet distant; thence North 36 degrees 49' 30" East, parallel to the center line of said highway 1071.5 feet to a 3/4" iron pipe and the true point of beginning of this description, thence North 89 degrees 41' 10" East, along the centerline of an existing irrigation ditch, as the same is presently located and constructed, 943.8 feet to a point; thence North 1 degree 54' 40" East 10.3 feet to an iron pipe reference monument; thence North 1 degree 54' 40" East 455.3 feet to a 3/4" iron pipe in the existing east-west fence which is generally accepted as the North boundary of the SE $\frac{1}{4}$ SW $\frac{1}{4}$ of said Section 30; thence South 89 degrees 59' 10" West along said existing fence 507.0 feet to a 3/4" iron pipe at the intersection with the Southeasterly Highway right-of-way fence; thence South 36 degrees 50' West along said existing right-of-way fence 587.7 feet, more or less, to the true point of beginning.
