This Agreement, made and entered into this

J. C. FOSTER, also known as J. CLIFFORD FOSTER $\hat{\kappa}$ CLARA M. FOSTER hereinalter called the vendor and husband and wife.

ERNEST A. JOHNSON and MARY HELEN JOHNSON, husband and wife, hereinatter called the vendee.

WITNESSETH

Vendor S agrees to sell to the vendeo S and the vendeo S agrees following described property situate in Klamath County, State of Oregon, to-wit:

> Lot 6 and the South one-half of Lot 7 of GARDEN TRACTS, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon

at and for a price of \$ 19,500.00

, payable as follows, to wit:

2,000.00 at the time of the execution of this agreement, the receipt of which is hereby acknowledged; 3,500.00 with interest at the rate of 81.5%per annum from date of contract payable in installments of not less than \$ 20().0() per month , in clusive of interest, the first installment to be paid on the 1st day of September 19 76 and a further installment on the 1st day of every month thereafter until the full balance and interest are paid.

Vendee agrees to make said payments promptly on the dates above named to the order of the vendor, or the survivors of them, of the First Federal Savings $\boldsymbol{\xi}$ Loan Association.

Oregon: to keep said properly at all times in as good condition as the same now are, that no improvement now on or which may hereafter be placed on said property shall be removed or destroyed before the entire purchase price has been paid and that said properly will be kept insured in companies approved by vendor against loss or damage by fire in a sum not less than \$x full ins. Value with loss payable to the parties as their respective interests may appear, said policy or policies of insurance to be held Vendors copy to Vendees that vendoe shall pay regularly and seasonably and before the same shall become subject to interest charges, all taxes, assessments, liens and incumbrances of whatsoever nature and kind . Taxes to be prorated as of date of contract.

and agrees not to suffer or permit any part of said property to become subject to any taxes, assessments, ilons, charges or incumbrances whatsoever having precedence over rights of the vendor in and to said property. Vendee shall be entitled to the possession of said property as of date of contract.

Vendor will on the execution hereof make and execute in favor of vendee good and sufficient warranty deed conveying a fee simple title to said property free and clear as of this date of all incumbrances whatsoever, except reservations, restrictions, easements and rights of way of record and those apparent upon the land; rules, regulations, liens and assessments of water users and sanitation districts.

which vendee assumes, and will place said deed

together with one of these agreements in escrow at the First Federal Savings & Loan Association,

at Klamath Falls, Oregon, and shall enter into written escrow instruction in form satisfactory to said escrow holder, instructing eaid escrow holder that when, and if, vendee shall have paid the balance of the purchase price in accordance with the terms and conditions of this contract, said escrow holder shall deliver said instruments to vendee, but that in case of default by vendee said escrow holder shall, on demand, surrender said instruments to vendor.

Escrow fees shall be deducted from the first payment made hereunder. The escrow holder may deduct cost of necessary revenue stamps from final payments made hereunder.

In the event vendes shall fail to make the payments aforesaid, or any of them, punctually and upon the strict terms and at the times above specified, or fail to keep any of the other terms or conditions of this agreement, time of payment and strict performance being declared to be the essence of this agreement, then vender shall have the following rights: (1) To foreclose this contract by strict foreclosure in equity; (2) to declare the tull unpaid balance immediately due and payable; (3) To specifically enforce the terms of this agreement by suit in equity; (4) To declare this contract null and void, and in any of such cases, except exercise of the right to specifically enforce this agreement by suit in equity, all the right and interest hereby created or then existing in favor of vendee derived under this agreement shall utterly case and determine, and the promises aloresaid shall revert and revest in vender without any declaration of foreiture or act of reentry, and without any other act by vender to be performed and without any right of vendee of reclamation or compensation for money paid or for improvements made, as absolutely, fully and perfectly as if this agreement had never been made.

Should vendes, while in default, permit the premises to become vacant, Vender may take possession of same for the purpose of protecting and preserving the property and his security interest therein, and in the event possession is so taken by vender he shall not be deemed to have waived his right to exercise any of the foregoing rights.

And in case suit or action is instituted to foreclose this contract or to enforce any of the provisions hereof, vendee agrees to pay reasonable cost of title report and title search and such sum as the trial court may adjudge reasonable as attorney's fees to be allowed plaintiff in said suit or action, and if an appeal is taken from any judgment or decree of such trial court, the vendee further promises to pay such sum as the appellate court shall adjudge reasonable as plaintiff's attorney's fees on such appeal.

Vendee further agrees that failure by vendor at any time to require performance by vendor of any provisions hereof shall in no way affect vendor's right horounder to enforce the same, nor shall any waiver by vendor of such breach of any provision hereof be held to be a waiver of any succeeding breach of any such provision, or as a waiver of the provision itself.

In construing this contract, it is understood that vendor or the vendee may be more than one person; that if the context so requires the singular pronoun shall be taken to mean and include the plural, the masculine, the feminine, and the neuter, and that generally all grammatical changes shall be made, assumed and implied to make the provisions hereof apply equally to corporations and to individuals.

This agreement shall bind and inure to the benefit of, as the circumstances may require, the parties hereto and their respective heirs, executors, administrators and assigns.

It is agreed by the parties hereto that the Vendors herein shall have the right, upon written notice to the Vendees and to the escrow holder herein, to increase the monthly payments upon this contract to offset any increase in the taxes upon the above described premises.

It is further understood and agreed that there is a certain Deed of Trust, including the terms and provisions thereof, given by J. Clifford Foster and Clara M. Foster, husband and wife, as grantors, to Transamerica Title Insurance Co, as Trustee for Equitable Savings & Loan Association, as beneficiary, which Deed of Trust shall be paid by Vendors and Vendors shall hold Vendoes harmless thereon. Also a Second Deed of Trust, given by J. C. Clifford and Clara M. Foster, husband and wife, as grantors to Transacmerica Title Insurance, as trustee for Glenn R. SMith, as beneficiary, which Deed of Trust shall be paid by Vendors and Vendors shall hold Vendees harmless thereon.


