## CERTIFICATE OF WATER RIGHT

This Is to Certify, That MEADOWS DRAINAGE DISTRICT

of P. O. Box 1825, Klamath Falls, State of Oregon 97601, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Four Mile Creek, Seven Mile Creek, and Anna Creek Slough for the purpose of a tributary of Agency Lake irrigation of 5378.3 acres under Permit No. 4791 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from September 13, 1920

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 67.23 cubic feet per second, being 14.41 c.f.s. from Four Mile Creek, 43.22 c.f.s. from Seven Mile Creek, and 9.60 c.f.s. from Anna Creek Slough

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Four Mile Cr.-Lot 3 (NW $\frac{1}{4}$  SW $\frac{1}{4}$ ), Section 18, Seven Mile Cr.-Lot 20, Section 6, Anna Cr. Slough-Lot 3, Section 5, T. 34 S., R. 7 $\frac{1}{2}$  E., W. M., 40 ft. South & 1350 ft. East from NW Corner, Section 5, 620 ft. North & 30 ft. East from SW Corner, Lot 20, Section 6, 2050 ft. North & 30 ft. East from SW $\frac{1}{4}$ . The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer. A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
