CERTIFICATE OF WATER RIGHT

This Is to Certify, That MEADOWS DRAINAGE DISTRICT

of P. O. Box 1825, Klamath Falls, State of Oregon 97601, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Wood River for the purpose of a tributary of Agency Lake irrigation of 15,962.6 acres under Permit No. 309 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from January 26, 1910

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 200.5 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 3, Section 3, T. 34 S., R. 7½ E., W. M., 2470 feet South and 940 feet East from NW Corner, Section 3.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
