GRANT OF EASEMENT

This indenture made the 16 day of September, 1976, between HOMER A. BARNES and HAZEL BARNES, grantors, and LOIS G. GOLDEN, grantee.

A ten-foot wide roadway easement and right-of-way which shall run from the northern most boundary of the above-described property to the southern most boundary of the above-described property and shall be located immediately adjacent to the eastern boundary of the eight-foot utility easement now in existence on the duly registered plat thereof.

This easement is for the benefit of and appurtenant to

that land or any portion thereof in the County of Klamath, State of Oregon described as Lot 3, Block 12 cf the Fourth Addition to Winema Gardens now owned by LOIS G. GOLDEN.

The grantee shall have all rights of ingress and egress over and upon said easement including the right from time to time to maintain and clear obstructions from said easement necessary for the grantee's use, enjoyment, operation and maintenance of the easement hereby granted and all rights and privileges incident thereto. The easement described above shall continue for an indefinite period of time and in perpetuity, always subject, however, to the following specific conditions, restrictions and considerations:

1. Any fence placed on the southerly end of said easement shall have a ten-foot wide free swinging gate across said easement; 2. Any fence or gate placed on the northerly end of said easement shall have not more than an eight-foot wide free swinging gate across said easement to allow passage.

The easement described herein is to and shall run with the land, and shall be for the benefit and use of LOIS G. GOLDEN, owner of the adjacent land described above, her heirs, successors and assigns.
