13 WHEREAS, a Decree of Divorce was entered in the above
 14 matter on the 16th day of June, 1966, nunc pro tunc to June 13, 1966;

16 WHEREAS, said Decree provided based upon a Property Agree-
 17 ment in addition to other matters that the Plaintiff would pay to the
 18 wife a monthly sum of \$100.00 per month as alimony, subject to her
 19 re-marriage, or death, and;

20 WHEREAS, there is now due and owing the sum of \$800.00 as
 21 alimony payments from the 1st day of February, 1976 to the first day
 22 of September, 1976, and;

23 WHEREAS, it is the desire of the parties to compromise
 24 and settle the provision for alimonies due by the Plaintiff to the
 25 Defendant;

26 NOW, THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES

1 HEREIN CONTAINED AND OTHER GOOD AND VALUABLE CONSIDERATION MOVING
2 BETWEEN THE PARTIES, IT IS HEREBY AGREED AS FOLLOWS:

3 (1) It is mutually agreed that upon payment of the sum
4 of \$1,000.00, payment of which is hereby acknowledged, the
5 Defendant hereby satisfies any judgment existing at this time for
6 alimony payments due to the Defendant.

7 (2) It is further agreed by the Defendant that the
8 Defendant does release and discharge the Plaintiff of any liability
9 for future alimony as of the date of the execution of this Agree-
10 ment and by this Agreement fully satisfies any judgment.

11 (3) It is further agreed by the Defendant that the
12 Plaintiff may file with the Court an Order deleting that portion of
13 the Decree providing for alimony payments to the Defendant.
