OWEN, husband and wife, hereinafter called the grantee, does hereby grant, bargain, sell and convey unto the said grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Klamath and State of Oregon, described as follows, to-wit:

Beginning at a point on the East line of Section 14, Township 39 South, Range 8 East of the Willamette Meridian, which is on the northerly right of way line of the Klamath Falls-Ashland Highway and which point is North 42.8 feet from the Northeast corner of the SE $\frac{1}{4}$ SE $\frac{1}{4}$ of said Section 14; thence along said right of way line South 53°20' West 319.78 feet; thence South 54°42' West 175.28 feet to the true point of beginning; thence continuing South 54°42' West along said northwesterly right of way line 110.28 feet; thence North 35°17' West 395 feet; thence North 54°42' East 110.28 feet; thence South 35°17' East 395 feet to the true point of beginning, being a portion of the E $\frac{1}{2}$ SE $\frac{1}{4}$ of Section 14, Township 39 South, Range 8 East of the Willamette Meridian.

and that grantor will warrant and forever defend the said premises and every part and parcel thereof against the lawful claims and demands of all persons whomsoever, except those claiming under the above described encumbrances.
