KNOW ALL MEN BY THESE PRESENTS, That G. FRED FOULON and JOAN FOULON, husband and wife

hereinafter called the grantor, for the consideration hereinafter stated, to grantor paid by JOHN W. HILDUM and RAE J. HILDUM, husband and wife, hereinafter called the grantee, does hereby grant, bargain, sell and convey unto the said grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Klamath and State of Oregon, described as follows, to-wit:

Beginning at the most Northerly corner of Lot 5, Block 47, Hillside Addition to the City of Klamath Falls, Oregon, thence Southwesterly along the line between Lots 4 and 5 of said Block, 50 feet; thence, Southeasterly parallel with the Northeasterly line of said Lot 5, 40 feet; thence, Northeasterly parallel with the Southeasterly line of said Lot 5, 50 feet to the Southwesterly line of Hillside Avenue; thence Northwesterly 40 feet to the place of beginning, being the Northerly 40 feet of the Northeasterly 50 feet of Lot 5, Block 47, Hillside Addition.

grantor will warrant and forever defend the said premises and every part and parcel thereof against the lawful claims and demands of all persons whomsoever, except those claiming under the above described encumbrances.
