KNOW ALL MEN BY THESE PRESENTS, That Walter W. the South half of the South half of the Northwest quarter of the Northeast quarter, and the North half of the North half of the Southwest quarter of the Northeast quarter; reserving therefrom a twenty foot easement on the West portion thereof, and existing easements of record.
