ROGERS, a single man, hereinafter called grantee, and unto grantee's heirs, successors and assigns all of that certain real property with the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, situated in the County of Klamath, State of Oregon, described as follows, to-wit:

The West one-half of lots 13, 14, 15, 16, Block 17, SECOND ADDITION  
to the City of Klamath Falls, Klamath County, Oregon, according to the  
official plat on file in the office of the County Clerk of Klamath County,  
Oregon.

Subject to all encumbrances, restrictions, reservations and rights-of-way of record and those apparent upon the land.

To have and hold the same unto the said grantee and grantee's heirs, successors  
and assigns forever.

The true and actual consideration paid for this transfer, stated in terms of dollars is \$2,020.00 (Two Thousand Twenty Dollars and no/100ths).
