KNOW ALL MEN BY THESE PRESENTS, That.....NANETTE BROWN

hereinafter called the grantor, for the consideration hereinafter stated, to grantor paid by MICK HOMES, an Oregon corporation, hereinafter called the grantee, does hereby grant, bargain, sell and convey unto the said grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Klamath and State of Oregon, described as follows, to-wit:

Lot 6 and one-half of vacated Summit Street adjacent to said Lot 6, Summers Heights, according to the official plat thereof on file in the office of the County Clerk of Klamath county, Oregon.

## SUBJECT TO:

1. Taxes for the fiscal year 1976-77, a lien but not yet due and payable;
2. Liens and assessments of South Suburban sanitary District and Klamath Irrigation District;
3. Conditions and restrictions as recorded July 11, 1950 in Volume 240, page 150, Deed Records of Klamath County, Oregon;
4. Reservations as contained in plat dedication;
5. Easements, if any, in and to that portion of vacated Summit Street.

Except as shown above, and that grantor will warrant and forever defend the said premises and every part and parcel thereof against the lawful claims and demands of all persons whomsoever, except those claiming under the above described encumbrances.
