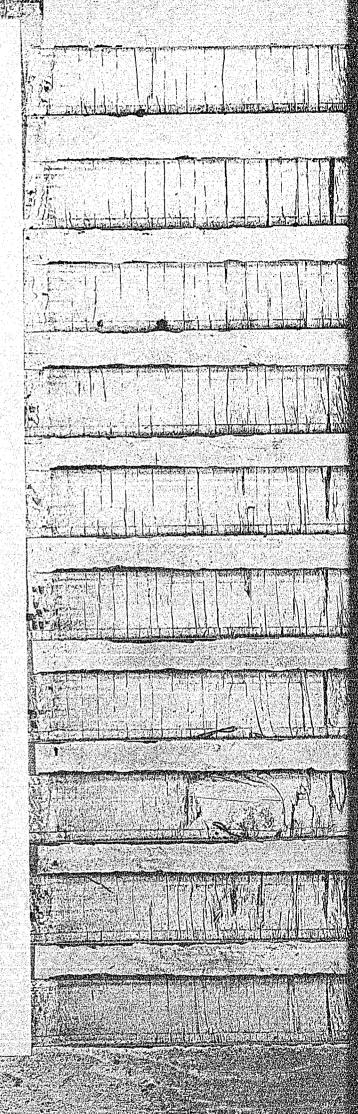

- 5. Not to permit any tax, assessment, lien, or encumbrance to exist at any time;
