LASLEY and LILA LEE LASLEY, HUSBAND AND WIFE, hereinafter called the grantees, does hereby grant, bargain, sell and convey unto the said grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of KLAMATH and State of Oregon, described as follows, to-wit:

Lot 4 and the West 1/2 of SE 1/4 of SW 1/4, in Section 19, Township 40 South Range 12 East of the Willamette Meridian, Klamath County, Oregon.

TOGETHER WITH and RESERVING THEREFROM a right of way for road and utility purposes, 60 feet wide, lying 30 feet on each side at the center line of the road described in Right of Way Agreement recorded in Volume 328, page 443, Deed Records of Klamath County, Oregon.
