

20806THIS CONTRACT, Made the 17 day of May, 1976, between
Milo H. Allen and Viola E. Allen, husband and wifeof the County of Klamath and State of Oregon, hereinafter called
the first party, and Lex M. Robinson and Gertie C. Robinson,
of the Countyof Jefferson and State of Oregon, hereinafter called the second party,WITNESSETH, That in consideration of the stipulations herein contained and the payments to be made
as hereinafter specified, the first party hereby agrees to sell, and the second party agrees to purchase, the follow-
ing described real estate, situate in the County of Klamath, State of Oregon, to-wit:

Lot 13, Block 18, SECOND ADDITION, KLAMATH RIVER ACRES, as
recorded in the Office of the County Clerk, Klamath County,
Oregon; SUBJECT TO: Reservations and restrictions contained
in the dedication and shown on the plat of the SECOND ADDI-
TION TO KLAMATH RIVER ACRES, as well as the Restrictive
Covenants which are attached to this agreement and by this
reference made a part hereof.

for the sum of Eight Thousand Six Hundred and no/100---- Dollars (\$ 8,600.00)
on account of which Five Hundred and no/100---- Dollars (\$ 500.00)
is paid on the execution hereof (the receipt of which is hereby acknowledged by the first party), and the re-
mainder to be paid to the order of the first party with interest at the rate of nine per cent per annum from
XXXXXXXXXXXXXX19XXXXXOKMx10xx and six months xx to followxx, balance of payments
as follows: The sum of \$500.00 to be paid on the 1st day of September,
1976, thereby making a total down payment of \$1,000.00. The remaining
balance of \$7,600.00 shall be paid as follows: monthly payments in the
amount of \$86.50, with said payments to begin on the 1st day of October,
1976, and with like payments to be paid on the 1st of each and every month
thereafter, until the full remaining balance of both principal and interest
be paid; with interest to run on the remaining balance at the rate of 9%
per annum. Also, interest shall commence running on the remaining balance
of \$7,600.00 as of September 1, 1976.

The buyer (also called second party) warrants to and covenants with the seller, that the real property described in this contract is
(A) primarily for buyer's personal, family, household or agricultural purposes,
(B) for an organization or (even if buyer is a natural person) for business or commercial purposes other than agricultural purposes.

Taxes for the current tax year shall be partitioned between the parties hereto as of the date of this contract. The second party, in consideration
of the premises, hereby agrees to pay taxes hereafter levied and all public and municipal liens and assessments hereafter lawfully imposed upon
said premises, all promptly and before the same or any part thereof become past due, that he will keep all buildings now or hereafter erected on
said premises insured in favor of the first party against loss or damage by fire (with extended coverage) in an amount not less than \$

in a company or companies satisfactory to first party, and will have all policies of insurance on said premises made payable to the first party as first
party's interest may appear and will deliver all policies of insurance on said premises to the first party as soon as insured. All improvements placed
thereon shall remain, and shall not be removed before final payment be made for and above described premises.

The first party agrees that at his expense and within 60 days from the date hereof, he will furnish unto second party a title
insurance policy insuring (in an amount equal to said purchase price) mortgaged title in and to said premises in the first party's name subsequent to
the date of this agreement, covered over the same and all encumbrances and restrictions and easements now or record; if any
First party also agrees that when said purchase price is fully paid and upon request and upon surrender of this agreement, he will deliver a good
and sufficient title in fee simple into the second party, his heirs and assigns, free and clear of all encumbrances as of the
date hereof and free and clear of all encumbrances since said date placed, permitted or arising by, through or under first party, excepting, however,
the said easements and restrictions and the taxes, municipal liens, water rents and public charges so assumed by the second party and further ex-
cepting all liens and encumbrances created by the second party or his assigns.

But in case the second party shall fail to make the payments aforesaid, or any of them, punctually and upon the strict terms and at the
times above specified, or fail to keep any of the other terms or conditions of this agreement, times of payment and strict performance being declared
to be of the essence of this agreement, then the first party shall have the following rights: (1) to declare this contract null and void; (2) to declare
the whole unpaid principal of said purchase price with interest thereon at once due and payable and/or (3) to foreclose this contract
by suit in equity; and in any of such cases, all the right and interest hereby created or then existing in favor of the second party derived under this
agreement, shall utterly cease and determine, and all the titles aforesaid shall revert and revert in the first party without any declaration of forfeiture
or act of re-entry, or without any other act by first party to be performed and without any right of the second party of reclamation or com-
pensation for money paid or for improvements made as absolutely fully and perfectly as if this agreement had never been made.

The true and actual consideration paid for this transfer, stated in terms of dollars, is \$ 8,600.00. However, the actual consideration
consists of or includes other property or value given or promised which is the whole consideration (indicate which).

And in case suit or action is instituted to foreclose this contract or to enforce any of the provisions thereof, second party agrees to pay such
sum as the trial court may adjudge reasonable as attorney's fees to be allowed plaintiff, and suit or action and if an appeal is taken from any
judgment or decree of such trial court, the buyer further promises to pay such sum as the appellate court shall adjudge reasonable as plaintiff's of
attorney's fees on such appeal.

The second party further agrees that failure by the first party at any time to require performance by the second party of any provision hereof
shall in no way affect first party's right hereunder to enforce the same, nor shall any waiver by said first party of any breach of any provision
hereof be held to be a waiver of any succeeding breach thereof or of a waiver of the provision itself.

In construction this contract, it is understood that the first party or the second party may be more than one person; that if the context so
requires, the singular pronoun shall be taken to mean and include the plural, the masculine, the feminine and the neuter; and that generally all
grammatical changes shall be made, assumed and implied to make the provisions herein apply equally to corporations and to individuals.

IN WITNESS WHEREOF, said parties have executed this instrument in duplicate; it either of the undersigned
is a corporation, it has caused its corporate name to be signed and its corporate seal affixed hereto
by its officers duly authorized thereto by order of its board of directors.
