to City of Klamath Falls, Oregon

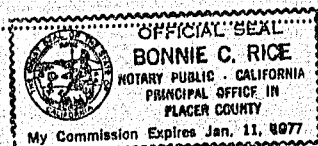

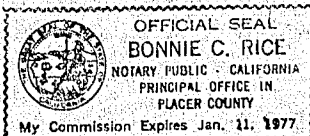
